Sub: Issue of Commercial Circular without the approval of the Commission.

PSPCL vide Commercial Circular No. 13/2013 issued vide memo no. 385/390/Voltage Surcharge/Sales-3 dated 11.3.2013, relaxed the Condition of Supply Clause 5.2 and General Conditions of Tariff Clause 13.3 without getting the approval of the Commission.

The Condition of Supply was approved by the Commission under Regulation 3.2 of PSERC (Electricity Supply Code & Related Matters) Regulations, 2007 and any amendment in the Conditions of Supply cannot be made without seeking the prior approval of the Commission. Similarly General Conditions of Tariff approved by the Commission, cannot be amended without prior approval of the Commission.

Directions in this regard were also issued by the Commission vide letters dated 8.8.2005 and 9.8.2010 wherein it has been clearly mentioned that all commercial circulars involving amendment/relaxation of Conditions of Supply approved by the Commission or issue which brings about change in liability of the consumers must be got approved from the Commission.

However, no such approval while relaxing the Conditions of Supply and General Conditions of Tariff vide above referred Commercial Circular was taken from the Commission. You are, therefore, advised to withdraw the Commercial Circular 13/2013 immediately and may file petition for seeking approval of the Commission for seeking any amendment in Condition of Supply and General Conditions of Tariff. Till withdrawal of this circular, its operation is hereby stayed.

Sub: Release of connection at voltage lower than specified to the industrial consumers- relaxation in Conditions of Supply Clause 5.2 and General Conditions of Tariff Clause 13.3.

To promote the industry in Punjab, the Govt of Punjab has adopted the Mega Project policy in order to make industrial atmosphere attractive. Various concessions to the industry are being given by Govt. of Punjab under this policy to promote industry in the State. During meeting of Industrialists/Industrial Associations with the Govt. of Punjab & Punjab State Power Corporation Limited, difficulty regarding release of electric connection to such Mega Projects at specified voltage is being highlighted, due to non availability of right of way for laying sub-transmission lines. The Industrialists pointed out that inspite of the fact that they have made large investment in setting up industry and even made full payments to PSPCL authorities for erection of these lines, they are unable to get electric connection at the specified voltage. This is hampering the growth of industry in the State of Punjab and industries are shifting to other states on this account. To overcome this problem, the matter was considered by WTDs in its 106th meeting held on 01.03.13 and it has been decided to release electric connection upto 4000 KVA contract demand at 11 KV voltage purely as a temporary measure to such Mega Projects sanctioned by Govt. of Punjab where the prospective consumers have already deposited the full cost of 66 KV Sub transmission line but the same could not be completed by PSPCL due to non technical reasons to be given in writing by the CE/TS.


It has also been decided that voltage surcharge to such type of consumers shall not be leviable till the actual conversion to 66 KV voltage takes place because of no fault on the part of such consumers.

This issues with the approval of competent authority.
